LOCATION

Peebles is an affluent market town situated 25 miles south-east of Edinburgh on the banks of the River Tweed in the Scottish Borders.

The subjects are located to the west of the town's High Street on the north side of the A72 just prior to young Street.

Nearby occupiers include British Red Cross, Two Rivers Veterinary Practice, Castle Warehouse and Charcoal Grill.

DESCRIPTION

The subjects comprise a single window shop/office unit with timber frontage arranged over ground and basement of a three-storey tenement.

Internally, the unit is well presented providing open plan space with a high ceiling. Lighting is provided by downlighter set within a ceiling mounted track and the floor covering is a textured

The basement provides good storage space and is accessed via a fixed staircase to the rear of the unit. It has carpet floor coverings, ceiling mounted light fittings and a WC compartment.
