LOCATION

The property is located within Partick, a prospering residential and commercial area forming part of the wider West End of Glasgow. Positioned on the eastern side of Keith Court, the subjects lie a short distance south of the arterial Dumbarton Road and Mansfield Park, with Kelvinhall Subway Station and the principal thoroughfare of Byres Road a short distance to the northeast. Partick Transport Hub affording access to bus and train links is also positioned within walking distance to the west. On street car parking is available outside the premises.

The immediate parade benefits from an eclectic mix of national and bespoke private traders with Tesco in occupation on the corner with Dumbarton Road while the wider area is also benefiting from the extensive redevelopment of the former Western Infirmary site by the University of Glasgow.

DESCRIPTION

The property comprises a modern refurbished Class 1A retail premises that benefits from a modern frontage with automated roller shutter, mezzanine level with dedicated lift access, store, tea prep area and toilets. The unit is formed on the ground floor of a modern four storey development holding a central position on the development's retail parade with residential dwellings above.
